44.1 TRANSMISSION CHARGES

The transmission charges contained in the basic rate per month provided in the rates schedules are provided below. Transmission rates are charged either on a kilowatt-hour or a kilowatt basis, depending on the rate structure of the class. The rates presented below are applicable to core rates schedules and to targeted rates, where, but for the targeted rate, the customers would take service under the core rate class.

The following transmission rates are included in core rate schedules that do not have a demand component:
